Miles Earning and Benefits of the Citi PremierMiles Card FAQs

1. What is the Citi PremierMiles Card?

This card is a fuss-free, travel-focused credit card that allows users to earn non-expiring Citi Miles on all of one's spends[#], which can be redeemed for a wide range of travel-related experiences and many other redemption options.

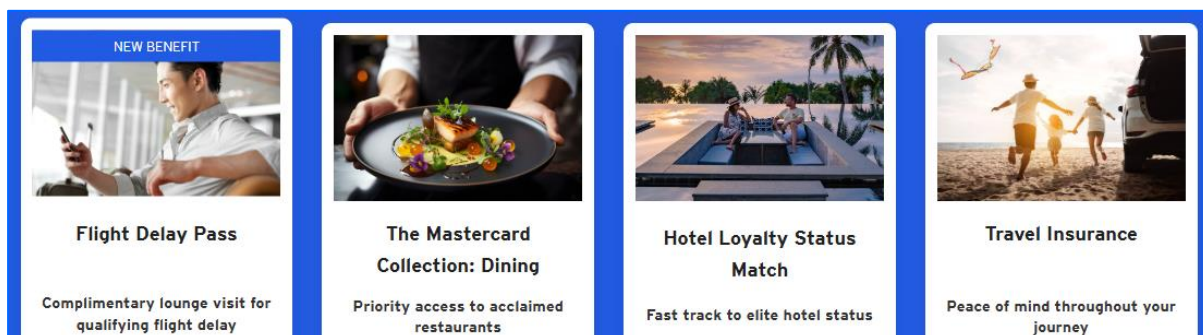

[^]Upon renewal of your annual membership, 10,000 renewal bonus miles will be credited to your account as part of the payment for your annual membership fee (S\$196.20 inclusive of 9% GST). In the event you wish to request for a waiver for your annual membership fee, the 10,000 bonus Citi Miles credited will be reversed from your account upon the completion of such waiver.

^{**}Priority Pass membership is on application basis and is reserved for the Principal cardmember only, limited to 2 complimentary visits per calendar year. Every accompanying guest will be considered as 1 visit. Thereafter, US\$35 per person per visit (or at the prevailing rate) will be charged to the Citi PremierMiles Card account. (Note: Priority Pass airport lounge charge of US\$35 per person per visit may also be charged in a different currency equivalent to US\$35 per person per visit.)

3. How do I earn miles on the Citi PremierMiles Card?

You earn Citi Miles whenever you use the Citi PremierMiles Card for eligible transactions[#], both locally and overseas. Higher earn rates apply to foreign currency spending.

Miles can be earned through:

- Everyday purchases such as dining, groceries, and shopping;
- Online and retail transactions across categories;
- Overseas transactions made in foreign currencies and more

4. Do Miles expire for the Citi PremierMiles Card?

No, Citi Miles earned on the Citi PremierMiles Card do not expire, allowing you to accumulate and redeem them at your convenience.

5. What can I use my miles for?

Citi Miles earned on the Citi PremierMiles Card can be used for the following redemption options:

- **Pay with Miles:** Offset purchases made on your card.
- **Redeem Vouchers:** Get vouchers for dining, shopping, and more using the Citi Mobile® App.
- **Apple Rewards Store:** Use miles to get the latest Apple products.
- **Kris+:** Convert miles to pay for purchases at participating merchants with Kris+.
- **Points Transfer:** Transfer your miles to participating airline and hotel loyalty programs.
- **Cash Rebate:** Convert your miles into a cash rebate on your card.

6. Are there benefits for overseas spending on the Citi PremierMiles Card?

Yes, foreign currency transactions on the Citi PremierMiles Card earn higher miles of 2.2 Citi Miles for every S\$1 foreign currency spent. This makes it valuable for international travel, cross-border shopping, and foreign currency payments.

7. Does the Citi PremierMiles Card offer airport lounge access?

Yes, the Citi PremierMiles Card includes 2 complimentary airport lounge visits per year for the Main Cardmember via Priority Pass, subject to the latest Citi Singapore programme terms. Find out more details from the [Citi PremierMiles page](#).

8. Is travel insurance included with the Citi PremierMiles Card?

Yes, only if you are holding onto the Citi PremierMiles World Select Mastercard.

9. Can I use the Citi PremierMiles Card internationally?

Yes, the Citi PremierMiles Card is widely accepted worldwide, making it suitable for international travel, online purchases, and foreign currency transactions.

Card Application FAQs

1. What are the eligibility requirements to apply for the Citi PremierMiles Card?

To apply for the Citi PremierMiles Card in Singapore, you will need to:

- Be at least 21 years old.
- Have a minimum annual income of S\$30,000 a year for Singaporeans/Permanent Residents, or S\$42,000 a year for foreigners.
- Provide valid identification and proof of income:

Documents for Singaporean/PR

If you are a Salaried Employee

- A copy of your NRIC/passport.
- Latest computerized pay slip or Income Tax Notice of Assessment.

If you are Self Employed

- A copy of your NRIC/passport.
- Last 2 years' Income Tax Notice of Assessment.

Documents for Foreigner

- A copy of your passport and work permit (with minimum 6 months validity).
- A copy of utility/residential telephone/home broadband internet bill (excluding mobile phone bill) or bank statement with your name and address.
- Income Tax Notice of Assessment and latest computerized pay slip.

2. Is there a referral program for the Citi PremierMiles Card?

Yes. If you are already a Citi Cardmember and would like to refer a friend, you can generate a referral invitation code [here](#) & share it with your friends. Your friends will have to apply via your referral invitation code and you will earn rewards with every successful referral.
