"Promotion" refers to the Citi PremierMiles – Agoda Up to 8 Miles for hotel bookings in Tactical promotion.

1. This promotion is valid for any pre-paid hotel bookings ("Eligible Booking") made:
 - (a) via the dedicated landing page at www.agoda.com/bonusmiles between 1 August to 31 August 2017 and for stay till 31 December 2017 (the "Promotion Period"); and
 - (b) with a Citi PremierMiles Visa Card or Citi PremierMiles American Express® Card issued by Citibank , including supplementary card(s) (each a "Card" and collectively, the "Cards");
2. Cardmembers of the Cards will be entitled to receive a bonus 6 Citi Miles per S\$1 spent ("Bonus Earn Rate") on any Eligible Booking in addition to the Citi Miles that the Cardmember would ordinarily earn for transactions charged to the Card ("Base Earn Rate")

5. Overseas Spend refers to retail transactions denominated in currency other than Singapore Dollars.
