

Citi PremierMiles Card - 4 Citi Miles on Food Delivery and Home Entertainment Promotion ("Promotion")
Terms and Conditions

1. Definitions

- a. "Citibank" refers to Citibank Singapore Limited.
- b. "Eligible Cardmembers" refer to main cardmembers of the Eligible Card. The spend on any supplementary card(s) shall be consolidated under the main Eligible Cardmember's account.
- c. "Eligible Card" shall refer to the Citi PremierMiles Card.
- d. "Promotion Period" refers to the period commencing on 1 March 2021 and ending on 31 August 2021 (both dates inclusive).
- e. "Eligible Transaction" refer to transactions made at any of the following selected food delivery or home entertainment merchants as determined by the following Merchant Description and Merchant Category Codes (MCC):

- g. A Merchant Category Code (MCC) is a four digit number assigned to a merchant/business by the merchant's acquiring bank. The acquiring bank provides the credit card payment facilities used by the merchant and it determines and applies (with respect to the account), the MCC which in its view best describes the merchant activity. Citibank does not determine the merchant's MCC.

2. Promotion Mechanics

- a. An Eligible Cardmember will be awarded additional 2.8 Citi Miles (“Bonus Citi Miles”) for every S\$1 spent on any Eligible Transaction charged to his Eligible Card within the Promotion Period.
- b. This Promotion will not be applicable with any existing accelerated rewards programs, any other promotion or discount/rebate arrangements.

- c. Subject to clause 2d below, Bonus Citi Miles will be credited into the Eligible Cardmembers’ Eligible Card account within ten (10) weeks from the date of the Eligible Transaction.
- d. An Eligible Cardmember whose Eligible Card is not in good standing or is otherwise closed/terminated and/or suspended (whether closed/terminated/suspended by the Eligible Cardmember or Citibank or for any reason whatsoever) at any time before the fulfillment of the Bonus Citi Miles will not be entitled to receive the Bonus Citi Miles on or after the date on which the Eligible Card is closed/suspended/terminated.

3. General Terms and Conditions

- a. Citibank has the right to debit from the Eligible Cardmember’s account, even if such debiting will cause the Eligible Cardmember’s account to go into a negative rewards balance, any miles already credited to such card account in respect of any refunded, cancelled or disputed Eligible Transactions or in the event that Citibank had erroneously credited these into the Eligible Cardmember’s account.
- b. Strictly no gaming of this promotion is allowed (for example if the transactions are not genuine transactions and conducted for the main purpose of gaining Citi Miles) and Citibank’s decision/determination on whether gaming of this promotion has occurred is final and binding.
- c. Citibank reserves the right at its reasonable discretion to terminate or amend the Promotion or vary, delete or add to any of these terms and conditions from time to time, without having to give prior notice or reason.
- d. Citibank shall not be responsible for the quality, merchantability or the fitness for any purpose or any other aspect of the products and/or services provided by third parties. Notwithstanding anything herein, Citibank shall not at any time be responsible or held liable for any loss, injury, damage or harm suffered by or in connection with the products and/or services provided by third parties.
